Public Works Report

The report was provided to Council in advance for their review and presented by Foreman T. Stefiuk. Public Works Foreman was asked by Council to speak to the concerns brought up by the landowner during the Open Forum. Foreman Stefiuk stated that the last time it snowed, before

this week, that 53 Street between 50 and 52 Avenue was the first residential road to be plowed. It has been 3 days since the last snowfall and Priority Areas 1-5 according to Roadway Snow & Ice Clearing Policy has been completed in addition to multiple residential roads; 53 Street between 50 and 52 Avenue is the next road to be completed but Public Works did not manage to get to it before the end of the workday today. Councillor B. Gray stated he would pass the information along to the concerned landowner.

Council asked Foreman Stefiuk to voice their gratitude to the Publics Works staff in the great job they are doing in keeping up with snow removal as it is much better than in many other municipalities.
