Census

The results of the 2016 Federal Census were released with a lower than expected population of 1,352. In 2011, the Federal Census stated that the population of Two Hills was 1,379 and a Municipal Census conducted by

the Town disclosed the population to be 1,431. Some government funding and grant are based on population therefore having an accurate population count is financially beneficial to the Town.

<u>Insurance – Curling Rink</u>

The insurance adjuster noted the settlement amount he is prepared to suggest to the insurers in the amount of \$2,632,633.20. The kitchen equipment and installation will be addressed separate from the building as well as the filling of the lines in preparation of the ice making.

Arena Upgrades - Tender

The Town was approved for a Canada 150 Infrastructure Grant for arena upgrades in the amount of \$188,475 and also approved for an Enabling Accessibility Grant to create a barrier-free washroom in the amount of \$9,450. The Town's contribution to the grants would be \$206,025.00. Grant applications were based on facility assessment review conducted by bedco drafting & design.

Council discussed the areas that require upgrades by priority and decided to start with subflooring, joist structure, and flooring.

2017-033 MOVED by Councillor S. Rajoo to direct the CAO to prepare a draft tender and bring to the next Regular Council meeting following estimates provided by Peter Bednarchuk regarding different flooring options.

<u>Infrastructure Funding Request to County of Two Hills</u>

The County of Two Hills is in the midst of budget preparations and with that in mind, Council felt it was a good time to put in a request to the County for infrastructure funding for the 2017 fiscal year.

An informal quorum decision was made and a letter was hand-delivered to the County on February 8, 2017 with the signature of the Deputy Mayor.

2017-034 MOVED by Deputy Mayor B. Gray to ratify the letter to the County of Two Hills thanking them for infrastructure funding in 2016 and requesting continued infrastructure funding in 2017.

<u>Arena Upgrades – Project Manager</u>

Council discussed the hiring of a project manager which would relieve direct oversight of the construction of the Arena renovations from the C.A.O. and the Public Works Foreman.
