- Roof leaks over FCSS; will have to monitor.

- Curb-out at 52 Avenue and Highway 36; still no confirmation from Alberta Transportation on whether they will be covering the cost of installation of a curb-out to match the other curb-outs for pedestrian access to the highway crossing signal.
- What can we do to avoid damage happening to bin lids and how to avoid improper garbage practices; perhaps place signs on the bins.
- Addition of swales to the recently paved intersection of 50 Avenue and 50 Street; PW monitored and assessed the flow and it was found to be sufficient as is; installing swale may wreck the integrity of the new surface.
