Summer Temporary Employment Positions:

The Town of Two Hills will be inviting applicants to apply for Summer Temporary Employment positions (STEP) with our Public Works and Administration Departments: This year's programs run anywhere from June to August 31, 2016. If interested, please drop off or mail a resume, and identify which Department you are interested in, by May 11, 2016

Must be:

- At least 15 years of age.
- A Canadian citizen, a permanent resident, or a person protected under the Canadian Immigration and Refugee Protection Act and legally entitled to work and study in Canada.
- International students and Temporary Foreign Workers and not eligible for STEP.
- Resides in Alberta with a Alberta Address.
- Returning to high school or a post-secondary institution to continue studying full-time in the fall.
- Must be enrolled in a program that will result in a Certificate, Diploma, or Degree.
- Technical training for Apprenticeship is not eligible
- Is available for full-time summer employment (30-40 hours per week) for a minimum of 4 consecutive weeks.
- Participated in only one STEP position during the summer.
- Not currently employed in the organization.
- Not immediately related to the owners or staff responsible for hiring in the organization

Highway 36 and Highway 45, at the Town of Two Hills Overview

Construction on Highway 36 within the Town of Two Hills will occur during the summer of 2016. The project, undertaken by Alberta Transportation, will include paving and the replacement of existing underground utilities, overhead illumination, sidewalk curb and gutter on Highway 36. The project will also include new illumination and intersection improvements at Highway 36 and Highway 45.

What to Expect :

Highway 36

Alberta Transportation will undertake significant reconstruction works along Highway 36 through the Town of Two Hills. The project will include the replacement of underground utilities such as water mains. Once the underground work is completed, the road will be re-graded and paved. In addition to paving, residents will notice new curb, gutters and sidewalk installation along Highway 36 as well as new illumination. Figure 1, at right, provides an example of a typical curb and sidewalk alignment at intersections on Highway 36 in the Town of Two Hills.

Intersection Improvements Highway 36 and Highway 45

A channelized right turn lane will be added at the intersection of Highway 36 and Highway 45 (see Figure 2, next page). This turn lane will facilitate the movement of large vehicles turning left onto Highway 45 from Highway 36.

As with any construction project, travelers may experience speed reductions, lane closures, detours and potential delays. Signage with additional information on construction timing will be posted on site prior to the commencement of construction activities.

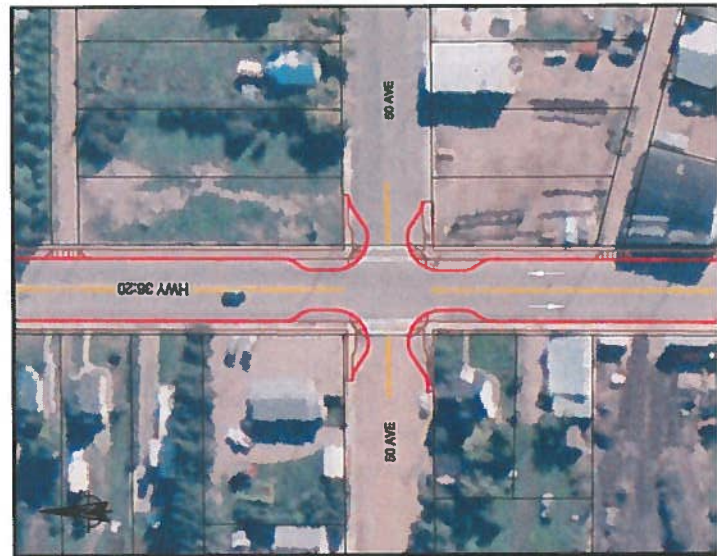


Figure 1. Diagram illustrating the typical new curb and sidewalk alignment (shown in red) along Highway 36 through the Town of Two Hills.

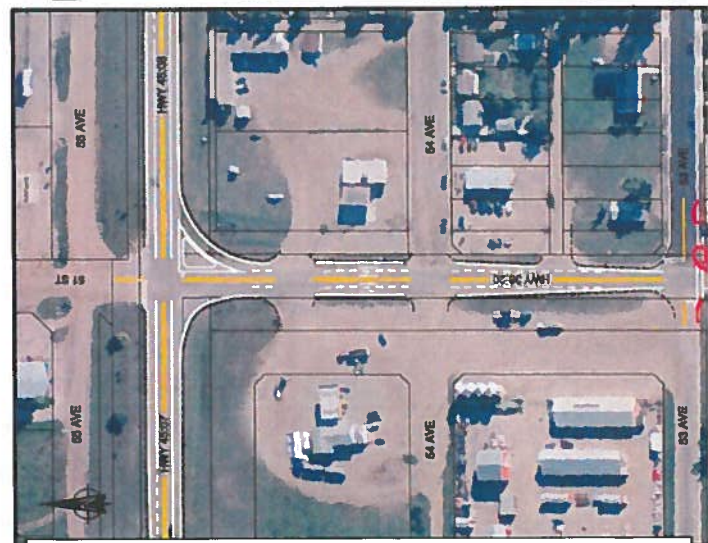


Figure 2. Diagram illustrating the intersection improvements at Highway 36 and Highway 45
