# **Geleta Park Gates**

Councilor W. Babiuk requested this item to be added to the agenda. Councilor W. Babiuk is concerned that the gates at Geleta Park are closed and locked therefore restricting public access. Gates are typically left closed during the winter months to deter traffic through the park. Discussion regarding when exactly the gates should be locked and unlocked for seasonal use was debated and was decided that the Public Works Foreman would have the responsibility to allow or deny access to Geleta Park based on environmental factors ie: weather, road conditions.

Furthermore, there was concensus from Council that a policy be drafted for the next Bylaw/Policy meeting respecting the opening and closing of Geleta Park gates, washrooms, etc.

# 2017 Voyageurs Rendezvous

The County of Two Hills expressed interest in becoming involved in a committee designed to welcome and entertain the Voyageurs and the

community when they stop in Duvernay on July 6, 2017. The Canada Day Committee was suggested to spearhead the Voyageur Committee by the County however the Chairperson for the Canada Day Committee expressed that their focus was to put on a Canada 150 event and a Heritage/Multi-Cultural day. There is a lack of volunteers for a Heritage/Multi-Cultural Day and they felt it was too close to the July 1st festivities and the volunteers would be spread too thin.
