Public Works Report

The Public Works Foreman's Report was provided to council in advance for their review and presented by Public Works Foreman T. Stefiuk. Council questioned where on the priority list does the sidewalk replacement at 52 Avenue west of Highway 36 fall? Public Work Foreman said it would be close to the top of the list. Council requested Public Works Foreman to provide a sidewalk priority list.

BYLAWS/ POLICIES:

2018-974 Property Tax Rate Bylaw

The 2018 Budget was passed at the last Regular Council meeting. Prior to setting of the budget Council deliberated on what the tax rates would be for residential and non-residential properties; the consensus was to set the Residential tax rate at 13.2 and the Non-Residential tax rate at 26.89. Council also had a consensus to have all minimum taxes, regardless of vacancy set at \$600.00.

2018-975 Maintenance Tax Bylaw

The Municipal Government Act permits a municipality, by bylaw, to impose a special tax for this purpose under Section 382(1)(f) to benefitting properties. So far, benefitting properties are any properties that are adjacent to a road, or water and/or sewer main lines (692 properties). The 2018 Budget was passed at the last Regular Council meeting which requires approximately \$89,000 in revenue from a special tax to cover cost of repair related to water, sewer, storm, roads and boulevards. This is approximately \$1.50 per front foot.

There are some properties that are fully or partially exempt from the maintenance tax; properties are listed within the bylaw under section 1(a).

The Municipal Government Act permits a municipality, by bylaw, to impose a special tax for this purpose under Section 382(1)(h) to benefitting properties (703 properties). The 2018 Budget was passed at the last Regular Council meeting which requires approximately \$26,166.43 in revenue from a special tax to cover the debenture that provides incentives to health professionals to reside and practice their profession in the Town of Two Hills (financial contribution to the new building).

The Municipal Government Act permits a municipality, by bylaw, to impose a special tax for this purpose under Section 382(1)(I) to benefitting properties (695 properties). The 2018 Budget was passed at the last Regular Council meeting which requires approximately \$23,204.19 in revenue from a special tax to cover the debenture that provides recreational services (financial contribution to the new rec facility).

NEW BUSINESS:

ATCO Electric – Change to LED Lights

ATCO Electric made a presentation at the January 23, 2018 and February 27, 2018 Regular Council meetings regarding costs to change from HPS to LED lights. This item was tabled until ATCO responded with more information.

Mayor L. L. Ewanishan has requested to return this discussion to the table due to verbal information that the City of Lloydminster and the Town of Vermilion signing on to upgrade their lighting to LED, there will be a lot of old lights added to the inventory, which would mean that the Town would be waiting for a long time for LED lights without going into a contract.

ATCO has provided a LED Conversion Letter and responses to Council's questions.

Proposal/Committee Appointment/ Approvals/Design

There was direction from Council after the last Regular Council meeting to add this item to the agenda. Councillor G. Saskiw requested the following to be discussed at this Regular Council meeting: committees, approvals, design, RFPs, funding, etc. next steps.

The Grow Arena Group should be providing a written proposal to the Town. The Grow Arena Group has indicated to members of Council to have an elected official from the Town and County to sit on the Grow Arena Group Committee.

Councillor M. Tarkowski attended the last Grow Arena Group meeting and provided a verbal report at this Council meeting.

Proposal re: Geleta Park and Centennial Hall

There have been meetings between members of Council and the Sports Activity Council (SAC) to discuss the management of Geleta Park and the Centennial Hall. During those meetings the Town has proposed the following (according to SAC's minutes): an annual amount of \$30,000, to pay for insurance and utilities, capital expenditures, maintenance and repair costs, use of Town equipment and summer students, and to cover any shortfall. SAC would conduct the bookings, collect and retain the revenues, and employ a caretaker who will work with the Town Foreman for scheduling of equipment and summer students. Council has recently been made aware that the Two Hills & District Agricultural Society is offering the use of their summer students to the Sports Activity Council.

SAC has proposed to manage Geleta Park for \$4,000.00 per month from May to September. Administration provided Council with the cost of the Town maintaining Geleta Park at roughly \$9,000 per season. SAC is currently looking at conducting the management of the Centennial Hall in the fall.

2018-163

MOVED by Councillor E. Sorochan that the Town allows the Sports Activity Council to manage Geleta Park in its entirety from May to September at \$4,000.00 a month.

Centennial Hall - Handicap Parking

Councillor G. Saskiw proposed a suggestion to make all the parking spots on the east side of the hall beside the sidewalk reserved for handicapped parking.

Council directed Administration to add two extra stalls at Centennial Hall; all major facilities will have four handicap parking stalls.

2018 SB-90 Projects

Councillor G. Saskiw requested this item to be added to the agenda. Town Council approved \$102,500 in the 2018 Capital Budget for rehabilitating roads. Administration and Public Works have provided some costs for rehabilitating the rest of 45 Avenue between 51 and 54 Street, 53 Avenue between 47 and 48 Street, 47 Street north of 53 Avenue, and 54 Avenue west of 46 Street. Administration and Public Works are also looking into costs for paving the intersection of 50 Avenue and 50 Street. Council requested more information about costs to rehabilitate 47 Avenue for the next Regular Council meeting.

Long Term Financial Planning Workshop

As of 2019 municipalities are to have 3 year operating and 5 year capital budgets. Administration is requesting approval from Council to have two staff attend a Long Term Financial Planning Workshop offered by the Government Finance Officers Association.
